Steps to certification

- 1. Check requirements for certification
- 2. Complete application through TEACH
- 3. Submit the Form for Requesting Warner School Recommendation in TEACH
- 4. Program completion
- 5. Certification awarded by NYSED



1. Check requirements for certification

Requirements for certification:

http://eservices.nysed.gov/teach/certhelp/CertRequirementHelp.do

- Do not need to complete program before submitting application
 - Can complete application at any time
 - If urgent for employment needs, superintendent's office can make use of <u>expedited service</u> procedure.
- **Do** need to complete program for certification to be awarded

 - Program completion
 - Institutional recommendation
 - Certification Exams
 - Fingerprinting



What's Included in Program Completion?

- Grades for all course work, including capstone project and internship, as applicable to program
- Workshops
 - NYS-approved workshop providers:
 - Child Abuse Prevention (CAP): <u>http://www.op.nysed.gov/training/caproviders.htm</u>
 - <u>NYS Office of Children and Family Services</u> no charge for CAP workshop
 - SAVE: <u>http://www.p12.nysed.gov/sss/ssae/schoolsafety/save/svpiproviders.html</u>
 - DASA: <u>http://www.highered.nysed.gov/tcert/certificate/dasa-applicant.html</u>
 - GV BOCES https://www.gvboces.org/Page/1352
- Conferral by the Board of Trustees (this happens on the official graduation date and applies to both CAS and MS programs)



Institutional Recommendation

- Confirms completion of program requirements
 - Academic work
 - Workshops
- Does not mean that certification is awarded
- Eliminates need to submit transcript.
 - be sure to choose the "NYS-Approved program pathway" in the application process



Certification Exams

- Educating All Students (EAS)
 - Required for all new certifications
 - additional certification in new subject area, (including SBL/SDL) will require EAS
- Content Specialty Test (CST)
 - SBL1 and SBL2
 - SDL1 and SDL2
- NYSTCE testing requirements will depend on the subject area(s) of certification.
 - www.nystce.nesinc.com
 - Be sure to send test results to University of Rochester
- Not required for program completion

2. Complete application through TEACH

Applying for certification:

- Apply through TEACH
 - Separate application for each Subject Area
 - Separate application for each certificate (initial and professional)
 - SDL professional certification only; no initial certification
- How to apply
- Completion of NYS Registered Program-need program code
- Valid for three years or two evaluations, whichever comes first
- NYS does not issue printed copies of time-limited (initial/internship) certificates
 - Consult <u>Duplicate/Printed Certificates</u> section of NYSED website
 - Print screen of TEACH account to show evidence of time-limited certificate

- All School Building Leader programs lead to initial AND professional SBL certification
- All School District Leader programs lead to professional SDL certification. There is not initial certification for SDL.



Timing of Application

- Can complete application for certification at any time
 - Do not need to wait for scores of CST's or institutional recommendation
 - Valid for three years or two evaluations, whichever comes first
- Can apply for jobs
 - School districts can access TEACH account
 - Print screen of TEACH account
- Recommended timing
 - Timing is specific to each individual
 - As requirements are met, will get checked off in TEACH



3. Submit the Form for Requesting Recommendation in TEACH

- Why do I have to submit this form?
 - Authorizes access to TEACH account
 - By hitting the submit button below, I hereby authorize the Certification Officer access to my social security number for the purpose of confirming my identification and acknowledging program completion to the NYS Office of Teaching Initiatives of the New York State Education Dept. (NYSED) via the TEACH system.
 - Every candidate does not intend on working in NYS public schools
- Submit the Form for Requesting Warner School Recommendation in TEACH



4. Program completion, including conferral

Program Completion Deadlines

- Not a submission deadline for capstone or other coursework (that information comes from your academic advisor)
- Is deadline for advisor notification (to Student Services) of completion
- Approximate deadlines for each grad cycle
- Also is deadline for submitting certificate of completion for workshops

Graduation Cycle	Deadline for advisor to confirm completion
August	Last Friday of July
October	Friday before Labor Day
December	Third Friday in November
February/March	Second Friday in January
May	First Friday of April
