Steps to certification

- 1. Check requirements for certification
- Submit the <u>Form for Requesting Warner School Recommendation</u> in TEACH
- 3. Complete application through TEACH
- 4. Program completion
- 5. Certification awarded by NYSED

1. Check requirements for certification

Requirements for certification:

http://eservices.nysed.gov/teach/certhelp/CertRequirementHelp.do

- Do **not** need to complete program before submitting application
 - Can complete application at any time
 - If urgent for employment needs, superintendent's office can make use of <u>expedited service</u> procedure.
- Do need to complete program for certification to be awarded

Institutional Recommendation


- Confirms completion of program requirements
 - Academic work
 - Workshops
- Does not mean that certification is awarded
- Eliminates need to submit transcript.
 - be sure to choose the "NYS-Approved program pathway" in the application process

Certification Exams

- Content Specialty Test (CST)
 - Subject specific
 - Consult certification requirements:
 https://eservices.nysed.gov/teach/certhelp/search-cert-reqs
 - School Counseling CST became requirement in 2024
- NYSTCE is provider for the exams.
 - www.nystce.nesinc.com
 - Send test results to University of Rochester
 - Consult chart (within exam details) for score reporting date
- Not required for program completion

2. Submit the Form for Requesting Recommendation in TEACH

- Why do I have to submit this form?
 - Authorizes access to TEACH account
 - By hitting the submit button below, I hereby authorize the Certification Officer access to my social security number for the purpose of confirming my identification and acknowledging program completion to the NYS Office of Teaching Initiatives of the New York State Education Dept. (NYSED) via the TEACH system.
 - Every candidate does not intend on working in NYS public schools
- Submit the <u>Form for Requesting Warner School</u> Recommendation in TEACH

3. Complete application through TEACH

Applying for certification:

- Apply through TEACH
 - Initial and professional certification
 - Separate application for each certificate (initial and professional; professional certification would be after three years' experience, most candidates do not complete this application upon program completion)
- How to apply
- Completion of NYS Registered Program-need <u>program code</u>
- Valid for three years or two evaluations, whichever comes first
- NYS does not issue printed copies of time-limited (initial) certificates
 - Consult <u>Duplicate/Printed Certificates</u> section of NYSED website
 - Print screen of TEACH account to show evidence of time-limited certificate

Timing of Application

- Can complete application for certification at any time
 - Do not need to wait for scores of CST's or institutional recommendation
 - Valid for three years or two evaluations, whichever comes first
- Can apply for jobs
 - School districts can access TEACH account
 - Print screen of TEACH account
- Recommended timing
 - Timing is specific to each individual
 - As requirements are met, will get checked off in TEACH
 - If urgent for employment needs, superintendent's office can make use of <u>expedited service</u> procedure.



4. Program completion

What's Included in Program Completion?

- Grades for:
 - all course work
 - capstone project
 - internship, student teaching
- Workshops
 - Completion certificates should be submitted to <u>certification@warner.rochester.edu</u> at least two weeks prior to graduation
- Conferral by the Board of Trustees (this is the official graduation date and applies to both CAS and MS programs)



5. Certification awarded by NYSED


